Payment & Cancellation Policy

MORE THAN 30 DAYS -If you cancel more than 30 days before the first day of class/camp, you will be subject to a 15% cancellation fee for a refund. This fee is based on the total amount of the class/camp at the time of registration (cancellation fee is not based on what you have already paid in the case of a payment plan, it is based on the total amount of the class or camp).

30 DAYS BEFORE -the first day of class through the class/camp ending date: Because your place was reserved, we regret we are unable to give refunds for any reason after this deadline except in instances of illness. In those cases, a doctor's certificate must be submitted and we can refund or prorate only up to a maximum of 50% of your tuition.

NO REFUNDS

There will be no refunds or prorating due to student absences.

CANCELLATION If a session must be canceled due to low enrollment and no other session is workable for you, we will refund all tuition and fees paid by you.

NON-TRANSFERABLE

Theatre school tuition and spots in our program are non-transferable.

The Parent/Guardian signing this agreement agrees to pay the required tuition.

Release

The Parent agrees to and does hereby release Grandstreet Theatre School from any and all liability for any illness, injury or damages suffered by the student during his/her camp experience, including participation in any athletic or recreational activity, in the absence of any gross negligence by Grandstreet or its staff.

Attendance

Regular, punctual attendance is encouraged at Grandstreet Theatre School. That being said, we are sensitive to the need for students to be absent due to observance of religious holidays or family emergencies. We ask that the student be proactive in catching up on any material that was missed (including blocking, choreography, music, handouts, etc.). When we have a short rehearsal process missing days, no matter the reason, may result in not being able to participate in a scene or number. We do our best to work around missed days, but it is not always possible to include someone in a number or scene when they have missed a significant amount of class or rehearsal.

Program Changes

Grandstreet Theatre School reserves the right to change faculty or programs without notification.
